Motion made by Milton Miller to have Vic Kohlhofer as the Moderator, seconded by David Frame, all in favor.

Moved by Leander Wagner and seconded by Ron Helms to get Township minutes of the past two years in a legal book, all in favor.

After a brief discussion it was said to post all public notices at the same places as before, Pahl's Supperette, Loni's Cafe, City Hall, the two Filling Stations and the New Market Bank. Connie Wagner made the motion, seconded by Ron Helms. All in favor.

Motion by Bruce Mohn and seconded by Ron Helms to include the Lonsdale Shopper in with the New Prague Times and the Lakeville Life and Times for publishing legal notices. All in favor.

Motion by Milton Miller seconded by Ron Helms that the hourly wage stay the same, \$5.00 per hour. All in Favor.

There was a discussion to do something in memory of Wm. J. Thalhuber for the years of service he gave to New Market Township. It was decided to have a plaque made and put in the new Town Hall when it is completed.

Motion by Bruce Mohn seconded by Leander Wagner, All in favor.

Martin Thomas made a motion to leave the Levy Budget the same, seconded by Milton Miller. All in favor.

The Moderator read all the budget but Road & Bridge.

There was discussion by Bruce Mohn on Town Board charges.

A motion was made by Milton Miller seconded by David Frame to leave the General Fund as is, all in favor.

Ron Helms made a motion to leave the Ambulance Service the same as last year \$9,000.00 to New Prague, seconded by David Frame, all in favor.

After a short discussion on the Watershed it was decided to leave them all the same, Vermillion, Sand Creek, and Credit River. Motion by Ron Helms and seconded by Bruce Mohn, all in favor.

The Fire Department represented by Gary Erickson and John Fuller were there to discuss the New Market Fire Department and its needs. Told us the name of the new fire hall shall be New Market Area Hall. In further discussion Gary said that they would use City money, Fire Fund money and Full Tab money before they would ask the Township for any of the \$250,000.00 and that they may not use all of the \$250,000.00. Asked about an account, Gary said that they have their own account at the Bank and that there was no schuffling of finances. John Fuller presented information on what the Fire Department did last year--- refered to numbers and hours. Motion was made by Ron Helms seconded by John Ott to ascept the 1996 Fire Contract of \$67,076.63 for New Market Township to pay, all in favor. After much discussion about the Capitol Fund of New Construction with the Fire Department members a motion was made by Ron Helms seconded by Bruce Mohn to accept the Capitol Fund of New Construction to the amount of \$18,064.00, motion carried, all in favor. Fire Fund Levy---Motion was made by Milton Miller to levy \$115,000.00 for the Fire Fund seconded by Martin Thomas, all in favor. Meeting adjourned at 10:28 p.m. with a motion by Milton Miller and seconded by Connie Wagner, all in favor.
