The minutes from the Feb 9, 2012 meeting were read. Motion by Chlan to approve the minutes as read with corrections to the spelling of Adlemann and changing the Ambulance Fund and Land Fund name from CDs to Money Market Funds. Seconded by Silverness, motion passed, all in favor.

Treasure's report was presented. Motion by Silverness to approve the Treasure's report as presented. Seconded by Chlan, motion passed, all in favor.

Tom Wolf – Scott County Commissioner – Talked on several issues concerning the County. Closing of the FSA office in Jordan, No recent news about the Race Track, No big road projects at the present time, County employees down to 700 from a high of 800, and roundabouts versus stop lights.

The renter of the Township Hall has requested a more permanent coat rack for the hallway. Chlan investigated the need and recommended purchasing a steel rack for approx \$200.00. Silverness made a motion to purchase a coat rack and sixty quality coat hangers. Seconded by Helmberger, motion passed, all in favor.

A Township resident inquired about the possibility of reserving the Park Picnic Shelter for a wedding reception and the cost. The Board stated that it is the intent to rent the shelter to residents and charge for it. The amount to charge has not been determined. The Board referred the request to the Park committee for input.

The 2012 Fire Contract with the City of Elko New Market was discussed. Motion by Silverness to get an explanation of the charges. Seconded by Chlan, motion passed, all in favor. Helmberger will follow up with the City.

The City of Elko New Market requests to annex a portion of the County Rd 2 frontage road that was turned back to the City. This portion of the road is still in the Township. No action taken, Helmberger will discuss with the City.

Scott County Highway Dept estimates it will take 36,438 pounds of material to crack seal the requested roads. The County will obtain bids to complete the crack sealing.
