Pledge of Allegiance

The minutes from the Oct 7, 2014 meeting were read. Motion by Mohn to approve the Oct 7 minutes. Seconded by Larson, motion passed, all in favor.

The minutes from the Oct 16 Special meeting were read. Motion by Larson to approve the minutes with changing initials SHE to SEH. Seconded by Mohn, motion passed, all in favor.

Sheriffs Report – Burglaries are in all Townships, occurring mostly during daylight hours when home owners are away at work. Officer Ryan gave several tips on trying to prevent thievery and to report all incidents to the Sheriff's office. He also mentioned the increased safety of roundabouts.

Jeff Pierret – 7375 250th St E – Had questions about the Fire Dept funding and Relief Association funding.

Jessamyn Kerchner – 2807 Dakota Trail, Prior Lake – requesting approval of splitting her 80 acre parcel at 7745 230th St E into two parcels consisting of a 10 acres on the east side of the property and the remaining acreage to stay with the buildings. Motion by Huntington to recommend approval of the split with the Township being notified where the driveway will enter 230th St. Seconded by Mohn, motion passed, all in favor.

Approve resolution for Woodland Hills lighting levy. The levy is presently \$57.00 each for the 26 home owners involved. Motion by Larson to approve the resolution with the statement the levy is for electrical lighting maintenance only. Seconded by Huntington, motion passed, all in favor.

Highview Estates – Drain tile on the north side of 236th St will be removed the week of 11/10/14.

Motion by Mohn to approve the Joint Powers Agreement for the County to do the assessing and the cost of the assessing. Seconded by Helmberger, motion passed, all in favor.

Motion by Mohn to approve the yearly renewal of liquor license for Red Fox Tavern. Seconded by Helmberger, motion passed, all in favor.

No Parking ordinance – delayed until the December meeting.

Treasurer's Report – Money in the account for road improvement is running low – levy money is available in December.

Road Report – Have been doing extra grading to get the roads in shape for winter.

Park Report – No action on unleashed dogs in Park.
